3. The bidder shall have experience in supplying gift vouchers/gift cards to Government Departments, PSUs, Co-operative Institutions, Corporate Organizations, or other reputed institutions.
4. The bidder shall either have at least one operational showroom/outlet in each of the 14 districts of Kerala, or the Gift Cards shall be valid and redeemable at any outlet across in Kerala.

2 Scope of Supply

The successful bidder shall supply **40 gift vouchers**, each having a **base value of ₹15,000/-**, and shall quote the **additional value offered over and above ₹15,000/- per voucher**. The quantity mentioned is approximate and it may increase or decrease based on the actual requirements.

Financial Bid

Bidders shall quote the **additional value (in ₹) offered per voucher above the base value of ₹15,000/-**.

Example:

- Base voucher value: ₹15,000/-
- Additional value offered: ₹500/-
- Total redeemable value per voucher: ₹15,500/-

Evaluation and Award of Contract

The tender shall be evaluated on the basis of the **highest additional value offered per voucher** over and above the base value of ₹15,000/-.

The bidder offering the highest additional value (H1 bidder) shall be considered for award of the contract, subject to meeting all eligibility criteria and other terms and conditions of the tender.
